At the end of FY 2025, CAHME accredited 160 programs at 106 universities, representing 8,935 full-time and 3,927 part-time students. CAHME facilitated approximately 81 of our 238 volunteers in conducting and reviewing 24 site visits during the current year.

The concerned individual refrains from participating in discussions or voting on matters related to that organization or individual.

If a conflict of interest arises, an appropriate disinterested person or committee will investigate alternatives to the business transactions, and after due diligence, if no alternative solutions are found, the board of directors determines by a majority vote of the disinterested directors whether the transaction is in CAHME's best interest and is fair and reasonable to CAHME. This process is documented in the executive committee minutes.

If the board of directors has reasonable cause to believe that an officer or director has failed to disclose possible conflicts of interest, it initially gives the individual the opportunity to explain the failure to disclose such conflicts of interest; after which the board of directors can decide whether to further investigate any potential violations and proceed with appropriate disciplinary action.

The executive committee of the board performs the duty of compensation committee for the CEO of the organization. The executive committee reviews the performance of the CEO annually. A salary survey and comparison of CEOs in other accreditation organizations is used as the guideline for the CEO's compensation. This was documented and last performed in July, 2022.

A salary survey and comparison of staff compensation in other accreditation organizations is used as the guideline for CAHME's staff compensation.
